



Дорогие Коллеги!

Проведённый в 2003–2011 годах анализ причин появления и условий существования демократического тоталитаризма или тоталитарного демократизма делает возможным его деконструкцию и учреждение мироустройства на разумных основаниях. Важным этапом такой трансформации является повсеместное смещение народных представителей, предводителей и надзирателей с ключевых должностей и замена их представителями научного сообщества на конкурсной основе. Предложение о введении процедуры замещения должностей на основе открытого участия и выбора наиболее способных и компетентных кандидатов вместо принятого в настоящее время всенародного голосования на выборах по партийным избирательным спискам было сделано в 2008 году (Andrej Poleev. The Tommyknockers complex, 2008). Поскольку от невменяемого по сути народа и избираемых им представителей нельзя ожидать того, что данное нововведение станет руководством к действию, научному сообществу необходима самоорганизация для проведения конкурсов. Для этого необходима определённая техническая основа, в частности создание независимых от академий наук комиссий и интернет–портала для выбора должностей, предлагаемых к замещению, для осуществления набора кандидатов, а также для контроля самого процесса отбора и принятия решения по замещаемым должностям. К сожалению, само научное сообщество в значительной мере коррумпировано и развращено демократическим тоталитаризмом; поэтому, в отличие от процедуры замещения вакантных должностей в научных учреждениях, необходимо сделать конкурсы максимально открытыми, а это значит: публиковать не только списки кандидатов но и возможно больше информации о самих кандидатах, а также предоставлять возможности для верификации всех этапов отбора, чтобы уменьшить вероятность принятия неправильных решений.

Поскольку речь идёт о замещении должностей не только в нашей стране, но также в других странах, необходимо координировать данный процесс путём интернациональной кооперации. В связи с этим я призываю русскоязычное научное сообщество инициировать преобразования и участвовать в них сначала на добровольной и безвозмездной основе. Прежде всего я обращаюсь к учёным, которые могли бы облегчить мне работу по переводу текстов на английский и другие языки. Также я ожидаю участия программистов для разработки технического обеспечения конкурсов. Не менее важно обеспечить приток средств для данного комплекса проектов, чтобы гарантировать независимость конкурсов от существующих академических и государственно–политических структур.

Первичную координацию мероприятий буду осуществлять я, в дальнейшем предлагаю передать эту функцию координаторам, ответственным за осуществление отдельных технических аспектов конкурсов. Пояснительный комментарий 7.09.2011.

Данному тексту предшествовал ряд умозаключений или логических шагов, о которых я хочу напомнить публике. Предложенное нововведение объясняется с одной стороны необходимостью ввести в политический процесс фильтр–защиту от демократического шума, избавив общество от хаоса непросвещённого сознания и неопределённости его целей и перспектив. С другой стороны, необходимо предоставить учёным возможность развития и самоопределения не только в сфере научных изысканий, но и дать им возможность реализации их знаний за пределами лабораторий и институтов, куда их заперло интеллектуально ограниченное демократическое большинство. Итог всякой познавательной и научной деятельности – развитие логического мышления, которое является самым ценным общественным ресурсом. Однако этот ресурс до сих пор имеет ограниченное применение и использование, а также подвергается деформации либо злоупотреблению в связи с демократической политической системой, в которой учёному отведена роль слуги народа или подчинённого самозванных народных элит. В стаде баранов нет и не может быть другой элиты, кроме той, которая возникает или в результате сексуальной конкуренции и поединков во время гона (если речь идёт о диких животных в естественной среде обитания), или в виде пастуха с овчарками (пример: В.В. Путин). Однако ни то ни другое социальное устройство неприемлемо для людей, покинувших логику естественного эволюционного отбора в связи с приобретением рассудочной деятельности. Следует оговориться: способностью к рассудочной деятельности обладают не все, а те, кто ею обладают, имеют различную степень её развития. Демократия противоречит эволюционному смыслу того, что называется человеческим сознанием и существом, поскольку интеллектуально неразвитое большинство не может и не должно диктовать учёному меньшинству правила жизни и навязывать ему что–либо, противоречащее здравому смыслу. Тирания народных

масс и интернационалы глупцов должны уйти в прошлое и стать предметом изучения историков и психиатров во избежание их повторения. Нет необходимости учить кухарок (в отличие от их детей) управлять государством, для всех будет лучше, если кухарок оставить на кухне и предоставить им заниматься тем делом, которое они могут делать лучше других. Если же предоставить им заниматься не свойственным им делом, то они заварят такую похлёбку, которую придётся расхлёбывать не одному поколению людей.

В своё время я был знаком с профессором Кухарским, которого его гомофобные и узколобые „коллеги“ выбросили из Университета. То же самое повторилось со мной в Германии. Я не буду спекулировать по поводу кухаркиных детей, способных на такие (зло)деяния, однако уверен, что от таких „коллег“ научному сообществу следует избавляться безжалостно и навсегда. Кроме того, в научное сообщество „благодаря“ излишней терпимости и неосмотрительности регулярно проникают крысы (примеров чему множество), от которых также следует избавляться.

Имеется только один проверенный способ стать и быть учёным с большой буквы*: непрерывно заниматься умственной деятельностью и развитием логического способа мышления, подобно тому как атлеты развивают их опорно-мышечный аппарат. Показателем развития ума и фактической способности к логическому мышлению является способность к научно-просветительской деятельности, проявлением чего могут быть публикации, изобретения, открытия, и любая другая активность, имеющая консистентный характер. Консистентность означает последовательность, согласованность, когерентность, логическая выверенность, адекватность, реалистичность. Как правило, приобретению всех этих качеств предшествуют обучение (так называемое высшее образование) и реализация приобретённого знания в конкретной жизненной ситуации, например, научная или инженерная карьера. Конечно, качество образовательного процесса, условия и предпосылки профессиональной деятельности, значительно определяют интеллектуальное развитие, и должны подвергаться корректурам по схеме обратной связи для устранения препятствий и недоразумений (пример; Angela Merkel). Поэтому часть учёных закономерно должна вовлекаться в учебный и политический процесс во избежание отсутствия обратной связи, что мы наблюдаем в демократии.

Критерии оценки индивидуальной интеллектуальной продвинутой необходимости для процедуры отбора в процессе занятия должностей в науке, политике, фабричном производстве, сельском хозяйстве. Как заметил один из комментаторов телевизионной дискуссии на тему об элите, элита означает отборные, лучшие, а значит элитой может быть всё что угодно, например отборные воры, взяточники, глупцы, идиоты, мошенники. Предлагаемые в данном тексте конкурсы должны решить проблему с отбором, кстати говоря проблему, которую успешно решали наши предшественники на протяжении тысячелетий, осуществляя селекцию плодовых растений и домашних животных. В данном случае речь идёт конечно не о генетической селекции неких супергероев в области интеллекта, а о необходимости выбора лучших для предоставления им возможности собственного развития в конкретном социальном контексте, что будет способствовать развитию сообщества в целом. Каждый человек, который развивает себя умственно, занимается общественно полезной деятельностью, однако необходимо также совершенствовать себя нравственно, чтобы уменьшить вероятность злоупотребления превосходным интеллектуальным состоянием, роста за счёт падения других, или паразитирования, следуя дурному примеру академий наук. Предлагаемые конкурсы – это подобие аукционов, однако средством платежа в них являются не деньги, а знания, опыт, научная квалификация, в приобретении которых деньги играют определённую роль, однако весьма ограниченную, поскольку ни научную репутацию, ни научно значимые достижения, не говоря уже об

умении рассуждать нельзя купить ни за какие деньги. С этих конкурсов должно начаться обновление всего общества, погрязшего в злоупотреблении и злонамерении, и опустившегося до скотского состояния „благодаря“ забвению селекционного искусства и неограниченному потреблению и пожиранию плодов интеллектуальной работы многих поколений предков и филогенетических предшественников. Необходимо начать обратный процесс возвращения к ценностям, которые нельзя купить ни за какие деньги.

О значении и смысле понятий деньги, валюта, обмен, аукцион, конкурс, транзикация можно ознакомиться в моих предыдущих работах или в материалах, доступных в интернете и библиотеках, поэтому соответствующие разъяснения я опускаю по понятным причинам, ограничившись лишь указанием на неслучайность их употребления. Более общее представление о теме данного манускрипта менее осведомлённый читатель может получить, ознакомившись с нижеперечисленными источниками:

* Является ли человек Учёным или неучем определяется как званием так и призванием, а также тем, насколько он соответствует смысловому содержанию понятия, имеющего следующие значения: мыслитель, мудрец, просветитель, просвещённый, знаток, интеллигентный человек, философ.

О научных степенях и званиях.

Одним из главных последствий путаницы с понятиями, определяющими уровень и область знаний (учённость, специальность), принадлежность к определённому виду интеллектуальной деятельности, является наблюдаемый в настоящее время всеобщий политический, экономический и экологический кризис. В связи с этим, необходимо дифференцировать между учёным, образованным, грамотным, интеллигентным и интеллектуальным человеком, а также по роду деятельности, принадлежности к определённой группе и специализации в определённой сфере знаний, например: врач (медик, Mediziner), академик (учёное звание по признаку принадлежности к академии наук), инженер (конструктор, архитектор, Baumeister), агроном, и т.д. Кроме того, хотя границы между прикладной и фундаментальной наукой, использованием знаний для решения технических задач по сравнению с их использованием с целью производства новых знаний, условны, однако существует традиционное разделение на научную и техническую интеллигенцию и специализацию деятельности. Итак, обратимся к самим этим понятиям, чтобы прояснить их смысл, значение и использование.

Что есть наука? Наука (нем. Wissenschaft, англ. science от лат. scientia знание) – это знания (нем. Wissen, англ. knowledge, греч. γνῶσις, лат. scientia) приобретаемые опытным (эмпирическим) путём и выверяемые в процессе научно-исследовательской деятельности, методологическими основами которой являются наблюдение, логическое размышление и эксперимент. Совокупность накопленных знаний закрепляется в письменном виде, объединяется и систематизируется в форме учений, и передаётся в черед поколений посредством обучения. Предпосылкой достижения качественного или фазового состояния ума, называемого учёностью, является период ученичества. Присуждение учёной степени подводит итог высшему образованию, и является символическим актом фазового перехода от ученика к учителю. В соответствии с этим, всякий доктор наук (от лат. учитель) наделяется правом передавать приобретённые знания, преподавать науку. Корневой основой латинских слов-синонимов educator (воспитатель, учитель) и doctor (учитель) является глагол do (давать, передавать), от которого происходят слова edo (отдавать, производить, рожать), и русское еда. Слово учёный (нем. Gelehrter, англ. scientist) имеет ряд синонимов: знающий (нем. Wissender, англ. knower, греч. πολυίστωρ), философ (от греч. φιλοσοφῶ тяга к знаниям, постижению мудрости или приобретению определённых профессиональных навыков), мудрец (нем. Weise, англ. prudent, греч. φροντιστής), мыслитель (нем. Denker, angl. reasoner thinker), интеллектуал. В качестве синонимов иногда употребляются слова исследователь (нем. Forscher, англ. researcher, explorer), эксперт, изобретатель, (перво)открыватель (нем. Entdecker, англ. discoverer). В отличие от учёного, школьник – scholar; грамотный человек – γραμματικός, eruditus; аутодидакт – αὐτοδίδακτος; всесторонне образованный – παντοδίδακτος.

Предметом всякой науки является достоверное (т.е. проверяемое экспериментальным путём) знание. Центральным понятием древнегреческой философской школы является понятие γνῶσις знание, которое однако оказывается недостаточным для передачи смыслового содержания его оттенков и дополняется понятиями: διάγνωσις понимание различия; καρδιогνώσις кардиолог; φραδὴ понимание; μάθησις учёба (приобретение знаний); σύννοια сознать; συνείδησις сообщение, информация; σοφία ум, умение; φρόνις мудрость; ἀκρίβεια точное знание; αὐτογνῶσις абсолютное знание; ἐπίγνωσις узнавание; ἐπίσταμαι достоверное знание. Верой становится то, что верно, истинно, поэтому корневой

основой слов ἐπίσταμαι, ἐπιστήτης (предмет науки, научное знание), ἐπιστημονικός (способность познания) является πίστις доверие, вера. В упомянутом смысле, термины эпистолог (англ. epistologist) и эпистология (англ. epistology) следует ввести в употребление в качестве международных эквивалентов слов учёный и наука*. Одновременно с этим, предлагается изменить название научной дисциплины о знании – эпистемологии (англ. epistemology), впредь употребляя форму эпистика (epistics), как это принято в ряде подобных случаев (лингвистика linguistics, эвристика heuristics, статистика statistics).

В отличие от знания в философском и научном смысле, практическое знание, имеющее утилитарную направленность и применяемое в производственной деятельности, обозначалось словом τέχνη. Техника – это область искусства, ремесла и прочего творчества, использующего, но не создающего знания. В то время как всякое образование направлено на обретение образа мироздания, техника использует это знание для преобразования естественного окружения и природных материалов, и создания на их основе искусственной антропогенной среды, начиная от одежды и заканчивая городами. В этом заключается разрушительный потенциал всякой техники, продукты которой зачастую противоречат мирозданию и нарушают его гармонию по причине отсутствия у их создателей фундаментальных знаний, доступных философам и учёным. В то время как экология – наука о естественном окружении, то экономика – это техническая дисциплина, полем деятельности которой является описание и организация (оптимизация) взаимодействия людей в процессе производства и распределения продуктов их трудовой деятельности. Для иллюстрации сказанного, показателен пример с автомобилем: в то время как шофёром может быть любой человек, научившийся водить автомобиль, процесс изготовления автомобиля (технология производства) известен только техническому специалисту – конструктору и инженеру, а наиболее полное понимание принципов его устройства и функционирования доступно лишь учёному–физику. Подводя итог сказанному, необходимо указать на качественное различие уровней знания: для учёных различных специализаций (историки, биологи, филологи и т.д.) характерна наиболее развитая познавательная способность и наиболее обширные знания; для технических специалистов, к которым можно отнести агрономов, инженеров, программистов, медиков, психологов и т.п., свойственно умение использовать знания, приобретаемые в процессе академического или аутодидактического обучения; представители прочих профессий – шофёры, рабочие, фермеры, военные, предприниматели, и т. п., как правило обладают уровнем знаний, достаточным для осуществления их профессиональной деятельности, не вникая в суть используемых ими инструментов, механизмов и процессов. Исходя из данных ранее определений, следует признать абсурдом высказываемые подчас суждения о необходимости введения научных степеней в области предпринимательской деятельности, поскольку они свидетельствуют о наличии когнитивных дефицитов, как правило связанных с отсутствием образования и навыков логического мышления, позволяющими интеллектуальное постижение предмета обсуждения. Не менее смешным выглядит перечисление профессий в Википедии, где все они свалены в одну кучу – начиная от палача, и заканчивая научным работником.

Одно из важных следствий, вытекающее из произведённого понятийного анализа, является необходимость создания и поддержания институтов выявления истинного (научного) суждения и мнения, и принятие их за основу в процессе постановки и решения вопросов общественно–политического и научно–технического развития. Достижению поставленной цели мог бы в значительной степени способствовать непрерывный семантический контроль с применением методов

психоанализа в отношении информации, публично распространяемой различными источниками. Также имеются веские основания для реформирования международной системы наименования научных степеней и званий, и устоявшихся традиций их присвоения. Разумным является введение научной степени доктора науки с присвоением учёного звания эпистолога, с одновременным сокращением количества необоснованных наименований (профессор, кандидат наук, PhD, ThD, EdD, BA, BS, MBA, MD и пр.). Другие научные звания – биолог, историк, октолог и т.д. можно было бы присваивать по мере освоения соответствующих образовательных программ и приобретения квалификации. Также представляется сомнительным необходимость написания и защиты диссертаций; вместо этого предлагается присваивать учёную степень и звание на основании реальных достижений, представляющих собой вклад в развитие науки, и публикаций, имеющих научную ценность.

* Слово эпистема означает наука, знание, и происходит от приставки ἐπι и глагола ἵστημι установить, встать, подняться, сбалансировать, упорядочить и пр. В то же время ὀτῆρ означает пенис (the exterior part of the membrum virile).

Lieber Interpol-Präsident,

In meinem Schreiben an den Generalsekretär von Interpol vom 21.04.2011 forderte ich ihn auf, den internationalen Haftbefehl gegen 4 Personen auszustellen (Anlage). In seinem Antwortschreiben vom 3.06.2011 (Office of Legal Affairs ref. LA/50410-29/34959-1/5.2/CAG/EVH/1b) verweigerte das Interpol-Generalsekretariat jegliche Anteilnahme; meine Forderung bleibt bis heute unerfüllt.

Über das geschehene Unrecht und die grausame Folter informierte ich gleichfalls die EU-Vizepräsidentin Viviane Reding, UN-Kommissarin für Menschenrechte Navanethem Pillay, Europäischen Gerichtshof für Menschenrechte sowie andere europäische und internationale Institutionen, die alle ausnahmslos versagt haben, ihre Funktion zu erfüllen. Die einzige Schlußforderung, die solche kollektive Verweigerung und Verdrängung zulässt, ist: In den europäischen und internationalen Institutionen amtieren blöde und unfähige Personen, die das Recht und die Ordnung garantieren sollen, aber in Wirklichkeit ihre Aufgaben grob vernachlässigen und sabotieren.

Die Menschenrechtskonvention wurde nach dem 2. Weltkrieg des 20. Jahrhunderts eingeführt, um die Wiederholung der Gräueltaten zu verhindern und die Willkür der Staaten zu beschneiden. Die Rechte haben Menschen, und die Staaten haben keine Rechte sondern Pflichte, die Menschenrechte zu garantieren. Sogenannte Staaten sind nur Bürokratenschwärme, die immer wieder versuchen, eigenständige Existenz zu erlangen und die existenzielle Rechte der Bürger unwirklich zu machen. Solche Staaten, in denen Willkür der Bürokratie über Menschenrechte Überhang nimmt, haben keine Existenzrechte, und müssen aufgelöst und umstrukturiert werden, um das richtige Verhältnis zwischen Recht und Pflicht wiederherzustellen.

In diesem Zusammenhang möchte ich in Erinnerung bringen, daß Interpol von ehemaligen SS-Offizieren wie Paul Dickopf (der Interpol-Präsident von 1968 bis 1972) mitaufgebaut wurde. Solche Leute bestimmen offensichtlich weiterhin eine internationale Organisation, die weltweit für Recht und Ordnung sorgen soll, aber in Wirklichkeit von obskuren politischen Eliten für ihre obskure politische Zwecke (d.h. Machterhalt und Verteidigung eines obskuren politischen System) mißbraucht wird. Das Bundeskriminalamt in Wiesbaden, das gleichfalls von Paul Dickopf und anderen ehemaligen SS-Diener aufgebaut wurde, ist Teil eines kriminellen Unrechtsstaates, in dem ich seit bereits 10 Jahren mit stillschweigender Zustimmung deutsch-faschistischer Bevölkerung mißhandelt und gefoltert werde.

Aus besagten Gründen stelle ich Sie vor die Wahl: Entweder sie erfüllen meine Forderung und verhaften Personen, die in meinem Schreiben an den Interpol-Generalsekretär genannt sind, oder treten Sie von Ihrem Posten zurück. Die Stelle des Interpol-Präsidenten wird dann neu ausgeschrieben und mittels eines in den wissenschaftlichen Kreisen üblichen offenen Auswahlverfahrens an eine kompetente, fähige und gesetzestreue Person vergeben.

Дорогая Генеральный директор ЮНЕСКО,

Я обращаюсь к Вам с требованием незамедлительного предоставления мне всех необходимых условий для реализации моей профессиональной деятельности. Моё обращение к Вам связано с тем, что в течение последних 10 лет у меня отсутствуют не только возможности для нормальной научной работы, но более того, я подвергаюсь злонамеренной политической травле, направленной на предотвращение моей научно-просветительской деятельности. Зачинщиками этой омерзительной охоты на ведьм являются в первую очередь немецкие профессора, действующие в традициях своих предшественников – нацистских преступников, которые не только подготовили две международные войны 20-го столетия, но и продолжили гадить по всему миру, разбежавшись как тараканы или крысы из немецкой кухни после разгрома фашистской Германии в 1945 году.

Я предлагаю Вам ещё раз прочесть дневниковые записи Виктора Клемперера (Victor Klemperer. „Ich will Zeugnis ablegen bis zum letzten.“ Tagebücher 1933–1945. 1997), сделанные им во времена Гитлеровской диктатуры, чтобы избавить меня от необходимости повторно излагать все ужасы, которые мне пришлось пережить в течение последних 10 лет, что стало возможно в том числе благодаря полному игнорированию моего существования международным научным и академическим сообществом, и несмотря на регулярное освещение творимого произвола в моём журнале.

С конца прошлого года я регулярно рассылал письма в научные учреждения, в которых появляются профессиональные вакансии, с целью возобновления моей научной деятельности, незаконно прерванной 10 лет назад. Результаты этого предприятия были предсказуемы: С таким же успехом я мог бы биться головой о бетонную стену в попытке её пробить.

В связи с вышеизложенным я требую отмены рабовладельческого строя, до сих пор насаждаемого свихнувшимися академическими элитами в университетах и научно-исследовательских институтах, и предоставления учёным самостоятельно определять место, время и объём научной работы, а также возможность публикации результатов и выводов их исследований.

Это требование однако неосуществимо без необходимости роспуска существующих академий наук, монопольно контролирующих средства, выделяемые на научные исследования и образовательные программы, и превратившихся в процессе монополизации в криминально-мафиозные синдикаты, действующие на конспиративной основе с целью узурпации власти и для личного обогащения их членов. Такое несоответствие целей и задач научного познания и творчества с архаичной

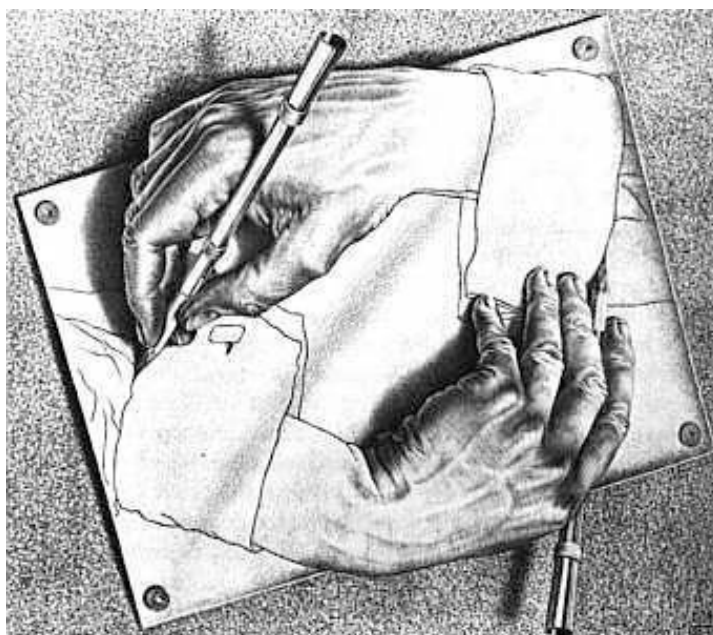
организацией академического сообщества привело к расцвету лженауки, выдаваемой за науку, к бессмысленной растрате средств, а также к противопоставлению науки общественному благосостоянию.

Возмутительные факты, о которых я сообщаю в данном письме, являются следствием монополизации в науке. В связи с этим я вижу необходимость распространения антимонопольного права на сферу производства и распространения знаний. Кроме того, я требую расследования обстоятельств, благодаря которым наука оказалась в данном состоянии. По результатам расследования должны быть сделаны выводы и проведены не только значительные корректуры организации научных исследований, но также лица, способствовавшие умышленному насаждению анти-научных организационных основ, должны быть наказаны в виде лишения права занятия научной и административной деятельностью, лишения научных званий и степеней.
